Adjournment to discuss urgent public matter (S.O. 26)

M. accepted, stood over for discussion the following evening at approx. 8.00 p.m., 6854-5, commencing after debate on statutory order, 6936

Matter important but one of continuing concern, might be raised again, 1289, 2448, 2834

Opportunity for discussion not lacking, M. not received, 893-4, 1289, 2296, 2448, 3992, 4723

Similar notices filed, giving ruling after motions presented, 1288

Bill

Advancing several stages in sitting, unanimous consent, 7228-9

Discrepancy with ways and means motion of last session, but identical with ways and means motion adopted this session, in order, 2507

Introduction, proper minister not sponsoring, deferring decision, 6743-4, objection well founded, but no precedent prohibits practice, may be useful argument in future, 7836-7

Introduction, should stand until seconder is in House, 7042

Omnibus bill, dividing, M. for 2r., committee and report stages offer opportunity to register vote on separate parts of bill, 5433, deferring decision, 5437, not within authority and responsibility of Chair, separate decisions at report stage may be made using motions to delete, without prejudice to arguments *re* procedural acceptability of said motions, 5522-4

Preamble, introducing at report stage, procedural acceptability not certain, but debate may proceed as House appears disposed to accept motion, 5085

Proclamation, not usual to delay, substantive changes prior to, only possible through legislation, 6452-3

Possibly beyond scope of bill, deferring decision, 7717, not in order, 7727

Seeking to amend act rather than amending bill, deferring decision, 7149-50, may be accepted with new subclause and unanimous consent, 7154-5

Similar to committee amendment, meaning changed, accepted, with consent of House, 7115

Similar to committee amendment, seeks to add another condition rather than new concept, in order, 7157-8

Minister tabling during question period, unanimous consent required, 7246

Private member appending to *Hansard*, not extending practice of consent, distribution services are available, 6584

Private member tabling, not in order, 2303-4, 3532, 5768, 6584

Referred to in ministerial statement, could not be tabled before statement, no unanimous consent to table after statement, ordering minister to read, deferring decision, 7366-7, 7371-2
