MR. PAPROSKI—NOTICE OF POSSIBLE QUESTION OF PRIVILEGE

Hon. Steven E. Paproski (Edmonton North): Madam Speaker, I should like to reserve my right to raise a point of privilege. When the minister stated, in answer to my question this afternoon, that I froze the multicultural budget, I think he was deliberately misleading the House. I would like to look at the blues and to reserve my right to bring forward a point of privilege.

MR. BEATTY—NOTICE OF POSSIBLE QUESTION OF PRIVILEGE

Hon. Perrin Beatty (Wellington-Dufferin-Simcoe): Madam Speaker, I should like to ask your permission to reserve my right to raise a question of privilege next week in a matter related to that raised by my leader today, but which is independent.

Over the course of your ruling today you gave the House information on how you viewed the possibility that the government's advertising might constitute a breach of the privileges of members of Parliament. On the basis of that information I should like to have the opportunity to review the government's advertisements relating to the energy program, the multi-million dollar campaign, which gives false information and may misrepresent the position of Parliament.

Second, arising out of your statement that questions of privilege should be argued on the basis of whether or not the government's actions impede the ability of members of Parliament to discharge their responsibilities, I will want to take a look at that advertising campaign to see whether a case can be made, as I believe it can, that that expenditure of tax dollars to seize control of the energy debate, which was the intention of the government when they brought it in, according to a confidential memorandum prepared by one of their officials, constitutes a breach of the privileges of members of Parliament. I would simply like to reserve my right to argue a question of privilege at some point next week, if it seems merited.

MR. McCAIN—NOTICE OF POSSIBLE QUESTION OF PRIVILEGE

Mr. Fred McCain (Carleton-Charlotte): Madam Speaker, like the member who has just spoken, I should like to refer to page 3728 of *Hansard* which indicates that the government House leader is of the opinion that the substance of what we have been discussing, that is, government advertising, in no way interferes with the fulfilling of the obligations of members of Parliament. Very briefly, members of Parliament seem to have been prevented from fulfilling their duties. The government House leader said:

In the present case, there is absolutely no alleged fact which shows that members of Parliament seem to have been prevented from fulfilling their duty.

On the basis of that statement I submit that my opportunity to fulfil the responsibilities I feel as a member of Parliament cannot be properly undertaken under the circumstances of the debate, its presentation by the government, and the suggestion of the government House leader. Like the former speaker, I
