Honourable Norman McLeod Rogers, minister of national defence, was killed at 1.25 o'clock today in the crash of an RCAF Lockheed "Hudson" aircraft en route to Toronto. The plane crashed into the woods ten miles west of Port Hope, Ontario, and caught fire after the crash. The cause of the accident has not been determined.

The pilot of the aircraft, who was also killed, was Flying Officer John James Cotter, of Halifax, Nova Scotia, who entered the RCAF in January, 1935.

Two members also killed were AC1 Oscar David Brownfield (R-51048) of Ottawa, Ontario, a son of Mrs. Minna Brown-
