#### LEVEL OF UNEMPLOYMENT—MOTION UNDER S.O. 43

**Mr. Lorne Nystrom (Yorkton-Melville):** Mr. Speaker, I rise on a matter of urgent and pressing necessity under the provisions of Standing Order 43. The May labour force survey showed that unemployment in Atlantic Canada has reached the tragically unacceptable level of 12 per cent. Unemployment in Quebec is up two full percentage points from May, 1976, to 10 per cent in May, 1977. This government's policies have increased regional disparity and cost young Canadians dearly. There are 403,000 unemployed between the ages of 15 and 24. Therefore, I move, seconded by the hon. member for Timiskaming (Mr. Peters):

That this House urge the government to immediately implement a policy of full employment.

#### REQUEST FOR GOVERNMENT ACTION TO CREATE JOBS— MOTION UNDER S.O. 43

#### UNEMPLOYMENT IN CAPE BRETON—MOTION UNDER S.O. 43

**Mr. Robert Muir (Cape Breton-The Sydneys):** Mr. Speaker, I rise under the provisions of Standing Order 43. My motion is prompted by the tragic unemployment situation existing on Cape Breton Island. In light of the announcement that there is to be a shutdown of a five-week duration at the Sydney Steel Corporation, which will add hundreds of additional unemployed to the ranks of an unemployment rate that is already the highest in the nation, and as a result of a largely attended public meeting of unemployed and others held in Sydney last night, I move, seconded by the hon. member for Cumberland-Colchester North (Mr. Coates):

That a team of expeditors from the Department of Manpower and Immigration and officials from the Unemployment Insurance Commission be immediately dispatched to Cape Breton Island to meet with the unemployed and municipal authorities to work out at least immediate short-term proposals to provide employment, particularly in view of the telegram that was sent to the Prime Minister and government ministers stating that if this was not done within 48 hours, further and more serious action would be taken.

#### RECOMMENDED CONTROL OF CHICKEN IMPORTS— ESTABLISHMENT OF NATIONAL MARKETING BOARD—MOTION UNDER S.O. 43
