JURY DISAGREES IN THE STRAHORN CASE

Prisoner Allowed Her Freedom—Other Cases in County Court.

In the county court yesterday the case of the King vs. Violet Strahorn occupied the morning session. Only one witness was called, Jessie Miller. The jury retired to their chamber at 11:45 and after staying out upwards of an hour, failed to agree, ten of the jurors in favor of an acquittal and two for a conviction. The girl was allowed her freedom, on the promise that she would be available at any other time, if the Crown thought fit to bring on a new trial.

Joseph Neaves, a soldier of the 140th, was tried for gross indecency. Shirley Taylor, Roy Vail and Privates Jas. P. Capson, Camille LeBlanc, George O. Hammy and Daniel Leighton gave evidence against the prisoner. The accused did not take the stand but made a statement. Neither counsel addressed the jury, who reached a verdict without retiring and found Neaves guilty of two acts of gross indecency with a recommendation that the prisoner be examined as to his sanity. No sentence was passed by His Honor Judge Armstrong, who, however, remarked that the battalion would be better for this man's removal. He will probably receive a stiff sentence in Dorchester as he seemed far from insane to those present in the court. E. S. Ritchie, as defendant, Attorney General Baxter prosecuting.

In the case of the King vs. Gerlie Nussent, for adultery, the accused pleaded guilty.
In the afternoon John Benace and Mesne John were tried for common assault. Mrs. Baker, Sarah Balcer and Meyer Gorgon testified against the prisoners, while they took the stand in their own defence. The jury found both guilty and they were remanded awaiting sentence. E. S. Ritchie appeared for the accused, and John A. Barry prosecuted for the Crown.

The case of the King vs. Fred McDonald, accused of theft from two men named Nichols being absent his deposition was put in evidence. The Crown's witnesses were Jas. D. Driscoll, George Riley, Detectives Barrett and Briggs, Capt. Lewis and the S. A.; they swore that the prisoner had stolen a pair of gloves and money to the amount of \$7.50. McDonald took the stand in his own defence; he admitted that he had stolen the gloves, and that he had served five terms in penitentiary since 1900, one of which was for five years, all for theft. The counsel addressed the jury and the judge will do so this morning. C. H. Ferguson appeared for the prisoner and John A. Barry for the Crown. Court adjourned to 10 o'clock this morning.

JURY DISAGREES IN THE STRAHORN CASE

Prisoner Allowed Her Freedom—Other Cases in County Court.

In the county court yesterday the case of the King vs. Violet Strahorn occupied the morning session. Only one witness was called, Jessie Miller. The jury retired to their chamber at 11:45 and after staying out upwards of an hour, failed to agree, ten of the jurors in favor of an acquittal and two for a conviction. The girl was allowed her freedom, on the promise that she would be available at any other time, if the Crown thought fit to bring on a new trial.

Joseph Neaves, a soldier of the 140th, was tried for gross indecency. Shirley Taylor, Roy Vail and Privates Jas. P. Capson, Camille LeBlanc, George O. Hammy and Daniel Leighton gave evidence against the prisoner. The accused did not take the stand but made a statement. Neither counsel addressed the jury, who reached a verdict without retiring and found Neaves guilty of two acts of gross indecency with a recommendation that the prisoner be examined as to his sanity. No sentence was passed by His Honor Judge Armstrong, who, however, remarked that the battalion would be better for this man's removal. He will probably receive a stiff sentence in Dorchester as he seemed far from insane to those present in the court. E. S. Ritchie, as defendant, Attorney General Baxter prosecuting.

In the case of the King vs. Gerlie Nussent, for adultery, the accused pleaded guilty.
In the afternoon John Benace and Mesne John were tried for common assault. Mrs. Baker, Sarah Balcer and Meyer Gorgon testified against the prisoners, while they took the stand in their own defence. The jury found both guilty and they were remanded awaiting sentence. E. S. Ritchie appeared for the accused, and John A. Barry prosecuted for the Crown.

The case of the King vs. Fred McDonald, accused of theft from two men named Nichols being absent his deposition was put in evidence. The Crown's witnesses were Jas. D. Driscoll, George Riley, Detectives Barrett and Briggs, Capt. Lewis and the S. A.; they swore that the prisoner had stolen a pair of gloves and money to the amount of \$7.50. McDonald took the stand in his own defence; he admitted that he had stolen the gloves, and that he had served five terms in penitentiary since 1900, one of which was for five years, all for theft. The counsel addressed the jury and the judge will do so this morning. C. H. Ferguson appeared for the prisoner and John A. Barry for the Crown. Court adjourned to 10 o'clock this morning.
