EMPLOYMENT, BONNE BAY PARK AREA

#### Question No. 2,656-Mr. Marshall:

- 1. How many are employed by the federal government in the proposed Bonne Bay Park area in Western Newfoundland?
  - 2. What type of work is being carried out?
- 3. Are the boundaries for the proposed area defined and is there agreement on these boundaries between the federal and provincial governments?
- 4. When is it expected that the land for the proposed park will be handed over to the federal government?
- 5. Has an agreement been signed between the federal and provincial governments for the establishment of the proposed Bonne Bay Park?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1 and 2. The Department of Public Works now has one man on the site preparing for camps and facilities. On July 28, D.P.W. will have eleven more men doing road location work.

Consultants have been retained by the National and Historic Parks Branch, Planning Division, to work on the preparation of the Park Master Plan.

- 3. A boundary proposal has been made to the Province of Newfoundland and is under consideration by them.
- 4. A start in handing over the land should be made within one year of an agreement, and all land should be in federal hands within 2 to 3 years of the agreement.

No. Discussions are underway with Newfoundland, Nova Scotia, New Brunswick, and Manitoba for the purpose of formulating economic development plans for each province on the basis of the new programs of the Department of Regional Economic Expansion. It is expected that similar discussions will commence shortly with other provinces.

Hon. H. A. Olson (Minister of Agriculture): No revision is presently contemplated for the Agricultural Stabilization Act.

Under Section 2 (1) (a) (ii) of the Act as it exists, Corn and Potatoes can quite adequately be looked after as designated commodities.
