# TWO BILLS HELD OVER.

Opposition Not Satisfied With Conmee Power Plan.

Sir Wilfrid Says Dominion Has Rights Also.

Ontario Government's Opposition to Canada Life Bill.

Ottawa, May 3.—The first session the eleventh Parliament entered upon its final stages to-day under peculiar circumstances. In the absence during most of the day of Messrs. Borden and Foster, the command of the Opposition seemed to have devolved upon Sir James Whitney, who was directing the battle from afar. Having amended his bill incorporating the Ontario & Michigan Power Co. to meet, as he thought, all the objections that had been offered to it, Mr. James Commee found, when the House got into committee, that he had reckoned without the Premier of Onreckoned without the Premier of On-tario. In the interval members of the Opposition had consulted Sir James as to the propriety of allowing the amended bill to go through, with the result that they appeared to-day with instructions to continue the opposition. The conse-quence was a blockade which lasted from 11 o'clock until 9 in the evening, when, recognizing the futility of continuing the recognizing the futility of continuing the discussion further, Hon. Mr. Fielding agreed to allow the bill to stand over for agreed to allow the bill to stand over for a few days more. The next bill on the order paper happened to be that of the Canada Life Assurance Company, and here again the Opposition were inspired by the Premier of Ontario. It appeared that the Ontario Government had a few days ago passed an order in Council de-claring that the bill interfered with the claring that the bill interfered with the property and civil rights of a large number of policyholders in the Province, and recommended, on that ground, that the legislation should be postponed until next session. Sir Wilfrid Laurier deand recommended, on that ground, that the legislation should be postponed until next session. Sir Wilfrid Laurier declined to be dictated to, declaring that he did not consider the Ontario Government had any right to interfere, but the Opposition, with Mr. Lennox as their chief spokesman, managed to impede the passing of the bill.

Mr. McCarthy (Calgary) called attention to the state of affairs created by the coal strike in the west, and asked the Minister of Labor whether he intended to enforce the law.

Hon. Mr. Lemieux said the latest reports were of a favorable nature, and he expected that within a few days a board would be constituted, and there would be no necessity of prosecuting those who had defied the law.

Mr. Armstrong suggested that the bill be sent back to the Committee on Private Bills, in order that the Ontario Government might have an opportunity of having its views presented.

Hon. Mr. Fielding agreed to the suggestion that there should be a few days' delay, in order that the Ontario Government might make their views known. He hoped that them the House would be able to deal with it without any further difficulty.

Mr. Henderson then moved that the Canada Life Assurance Company's bill be referred back to the Committee on Standing Orders for further consideration, and report as to the sufficiency of the notice given to the public. Messrs, Lennox, Porter, Sharpe (North Ontario) and Dr. Sproule supported the motion, which, however, was defeated.

Mr. Lennox then moved that the bill be referred back to the Committee on Banking and Commerce, on the ground that the policyholders might be heard, and that the Ontario Government might have a further opportunity of considerhave a further opportunity of con ing the question. He appealed to the Prime Minister to give weight to the or-der in council passed by the Provincial Government.

Sir Wilfrid Laurier pointed out that the bill had been considered by the Banking and Commerce Committee and found satisfactory. When it came be-fore the House the objection was taken that insufficient notice had been given and it had been referred back to the Standing Orders Committee for further consideration on that point. He was satisfied that the notice given had been satisfied that the notice given had been ample. "As to the order in council referred to," said Sir Wilfrid, "I do not see that the Government of Ontario have any right at all to interfere in this matter. It is not a question of Provincial siette."

matter. It is not a question of Provincial rights."

Mr. Turriff thought the policyholders should have an opportunity to present their views. Many of the policyholders, he said, were dissatisfied with the bill, and he believed that the Government would make a mistake if they forced the legislation through. The Government had no right to stop litigation, and no harm would be done if the bill was allowed to stand over until next session.

Mr. Clarke declared that delay would mean the undoing of the company, the shareholders and the policyholders, and as a policyholder he protested against a course that would have that result.

Mr. Goodeve vigorously supported the motion for postponement.

Mr. Guthrie believed that it would be

disastrous to both the company and the policyholders if there was delay. If a poncynoiders if there was delay. If a wrong had been done by Parliament in the past it should be corrected at once. Mr. Nesbitt pointed out that the Can-ada Life Assurance Company were not seeking anything that every other in-

In the meantime, one of the party produced a document written in French, which was all Greek to Chief Hall, and demanded the release of the prisoner. The mob pulled and pounded Chief Hall all the way from Lachine to Dorval, having him out on the platform twice. The last time he was forced to release his man, who was taken off the train by the mob. The mob also rifled Chief Hall's pockets of his money, leaving him without a cent.

The attorney acting for the Crown will be in Morrisburg to-morrow to investigate the matter.
