

- (1) As from the date of this note all Italian nationals arriving by air as members of the personnel of aircraft employed on regular Italian lines and registered in Italy or the Italian Colonies of Libya, Eritred and Italian Somaliland, or the Italian dependencies in the Egent Islands may enter the United Kingdom of Great Britain and Northern Ireland and all parts of the British Empire which are not separate members of the League of Nations, Canada, the Commonwealth Australia, New Zealand, the Union of South Africa, and India, upon the production in line of the the production, in lieu of national passports, of certificates of identify in the form of which a specimen is hereto attached.
