EXCHANGE OF NOTES (MAY 21 AND JULY 13, 1946) BETWEEN CANADA AND BELGIUM CONSTITUTING AN AGREEMENT IN SETTLEMENT OF WAR CLAIMS

EXCELLENCY,

I have the honour to refer to the basis of settlement reached between a representative of the Deputy Minister of National Defence and officials of the Belgian Government for payment by the Canadian Government for goods, services and facilities supplied by the Belgian Government to that part of the Canadian Army serving as part of the British Twenty-first Army Group in the North Worth Williams made by Belgian nationals in North West European theatre of war, and claims made by Belgian nationals in respect of damage caused by members of the Canadian Army, but excluding moral turpitude and war damage claims, for the period from the date of arrival

of the Canadian Army in Belgium until November 8th, 1945.

The Canadian Government has undertaken to pay twenty-five million, five hundred and fifteen thousand two hundred and thirty-two dollars in settlement in of all claims of the Belgian Government against the Canadian Government in respect of goods, services and facilities supplied to that part of the Canadian Army serving in the North West European theatre of war, and claims made by Belgian nationals in respect of damage caused by members of the Canadian Army (excluding moral turpitude transpired and war damage claims) for the period from the date of arrival of the Canadian Army in Belgium until November 8th, 1945. Of the above amount of twenty-five million, five hundred and fifteen than thousand two hundred and thirty-two dollars, an amount of nineteen million five hundred thousand dollars has been paid into the Bank of Canada, Ottawa, for credit of the Banque Nationale de Belgique. The balance of six million fifteen thousand two hundred and thirty-two dollars will be paid into the same account at any time at the request of the Belgian Government.
