## NEW PARLIAMENT BUILDING.

## \* Hon. Mr. MURPHY (Russell):

1. What has been the cost of the new Par-

liament Building to date?

### Hon. J. D. REID:

1. \$6,954,116.15 to 28th February, 1920.

The contractor is to receive eight per cent on the total cost of the building, dating from February 3, 1916, up to the amount of four million dollars, and seven per cent on the cost in excess of that amount up to the further sum of one million dollars, it being understood and agreed that the contractor is not to receive any commission on the cost in excess of five million dollars, said cost to be exclusive of the architect's and contractor's commissions, and the cost of structural steel.

3 and 4. The architects receive a fee of five and one-half per cent on the total cost of the work of reconstructing the Parliament Buildings exclusive of the percentage paid Messrs. P. Lyall & Sons Construction Company, Limited; it being understood that the commission of five and one-half per cent is to apply to an amount not to exceed the sum of five million dollars.
