MONTREAL—STEPS TAKEN FOLLOWING MAIL BOX EXPLOSIONS

On the orders of the day:

Mr. Remi Paul (Berthier-Maskinonge-Delanaudiere): My question is directed to the Postmaster General (Mr. Denis), but first, since he is a native of my riding, I should like to congratulate him upon his appointment.

Could the minister tell us what steps his department intends to take about the explosions in Montreal, yesterday and today, which have damaged five mail boxes, property of the Post Office Department.

Hon. Azellus Denis (Postmaster General): I wish to thank my hon. friend for his congratulations. Indeed, five mail boxes were destroyed by bomb explosions. Also, this morning, four more mail boxes had to be covered with sand to prevent any accident.

Sergeant-major Walter Leja defused the first two bombs, but was unfortunately killed while trying to defuse the third one.

I wish to take this opportunity to offer my deepest sympathies to his family.

Now, in the face of this danger, we have decided to use trailers to remove these mail boxes and transport them to a safe place. We have taken this course of action after having received phone calls and after having been warned by those who are clearing letter boxes that they contained bombs. We have decided to take this action and we shall have to continue to do so. I believe that after 12 hours the danger will have disappeared. We have notified the municipal police authorities who are searching for the offenders, while setting up a special watch. I am waiting for more news from Montreal on this matter.

ALLEGED CONTINUATION OF PATRONAGE IN DEPARTMENT

Hon. Azellus Denis (Postmaster General): Mr. Speaker, since we came to power only a few weeks ago, I do not feel we are responsible for everything that was done in the past under the Conservative government. But, at any rate, I do not think the Liberal party has any lesson to be taught, especially from the Social Credit party.
