Mr. Woolliams: Do I gather from the Prime Minister's answer that he goes along with the opinion of the President of the Treasury Board that in dealing with amputees and veterans who have served our nation they are redundant when it comes to lay-offs and have no priority in spite of the Public Service statute which guarantees them priority?

Mr. Trudeau: Mr. Speaker, I am asked if I am in accord with the opinion to that effect of the President of the Treasury Board. That is not his opinion. The member has misquoted his position.

Mr. Woolliams: Mr. Speaker, I rise on a question of privilege. The Prime Minister said I have misquoted the President of the Treasury Board. I will let the record speak for itself. I do not think influence is coming from the President of the Treasury Board but is coming from the Prime Minister who is not serving humanity.

Some hon. Members: Hear, hear!

Mr. Speaker: Order, please. That is not a question of privilege and I doubt whether we should pursue the matter further. I do not want to be unfair to the Prime Minister by not allowing him to reply to the statement made by the hon. member for Calgary North, but let me say again I think there is no question of privilege.

Mr. Basford: The government's reaction to the report of the Economic Council on competition will be shown in the bill which we intend to introduce to revise the Combines Investigation Act.
