TABLING OF LeDAIN COMMISSION REPORT— REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Frank Howard (Skeena): Mr. Speaker, pursuant to Standing Order 43 which permits a motion to be moved by unanimous agreement in cases of urgent and pressing necessity after an explanation has been given by the mover, I seek consent to move such a motion preceded by an explanation as to the urgency and the necessity for taking action quickly.

As every day goes by the misuse and abuse of drugs in this country becomes wider and wider, with the problem multiplying in intensity particularly among our younger people. Inasmuch as the public paid for the LeDain commission to conduct an inquiry into the subject matter of the non-medical use of drugs, inasmuch as the interim report of the commission has been before the minister for some two or three weeks, as well as before the cabinet, inasmuch as we are not asking for a decision on what the government intends to do with respect to the recommendations in the interim report but are simply asking the government to make available to the public a report which they paid for, in view of the growing abuse of the use of drugs I ask unanimous consent to move the following motion:

This House expresses the opinion that the government should forthwith table the interim report of the commission of inquiry into the non-medical use of drugs.

Mr. Speaker: Is there unanimous consent?

Some hon. Members Agreed.

Some hon. Members: No.

Mr. Speaker: There is not unanimity and therefore the hon, member's motion cannot be put.

Mr. Howard (Skeena): Mr. Speaker, on a point of order, may I point out that there is not unanimity within the cabinet committee that is studying this question either.
