FARM PRODUCTS MARKETING BILL—SUGGESTED REFERENCE TO SUPREME COURT OF CANADA

Mr. Eldon M. Woolliams (Calgary North): In light of the Prime Minister's answer with regard to Bill C-176, which he feels can remedy the present situation of no free trade between the provinces, I should like to ask him whether he is prepared to refer that bill to the Supreme Court of Canada to determine whether it is intra vires or ultra vires and thus confirm or otherwise the position he has taken in the House as to its constitutionality?

Right Hon. P. E. Trudeau (Prime Minister): The bill is before the House. Surely the proper procedure is for the House to adopt the bill and then, if some citizens believe it to be ultra vires, they can refer it to the Supreme Court. The government of Canada obviously drafted the bill with the advice of its legal officers and we have presented a bill which in our view is fully constitutional. I find it strange that when we are being told by many provinces that this bill is needed to remedy the situation, the opposition—

Mr. Speaker: Order, please. I do not think I should interfere unduly, but it seems to me we are again, as we did yesterday for a good part of the question period, engaging in a debate on Bill C-176 which is otherwise before the House.

Mr. Woolliams: May I ask one more supplementary question, because this is important. We shall not even have a parliament if confederation breaks up, and that is what we are talking about. I should like to put this question to the Prime Minister. In view of the fact there are plenty of precedents for the government of Canada asking the Supreme Court to determine the constitutionality of legislation would the Prime Minister be prepared to take such a course—yes or no?

Mr. Trudeau: The answer is no. I must add, Mr. Speaker, that it is difficult to understand how, the government having proposed a measure which would precisely prevent the balkanization of Canada—

Mr. Horner: You will balkanize Canada.

Mr. Trudeau: A request for marketing boards by the agricultural section of the economy has been made at least since I have been around, and now the government is at last moving forward with such a bill. The government has caused it to bog down for more than a year in the House and now they are suggesting it be delayed further by the making of a reference to the Supreme Court of Canada.

Mr. Speaker: Order, please. Hon. members will be recognized, but we have to give others an opportunity to ask questions.

I might add that this needs co-ordination at the ministerial level, and I have asked the energetic Minister without Portfolio responsible for housing to ensure this co-ordination between the various departments.
