POSSIBLE ESTABLISHMENT OF MINISTRY—POSITION OF PROVINCES

Mr. Georges Valade (Sainte-Marie): Mr. Speaker, in view of the importance of the subject of my question, as well as the importance of its constitutional aspect, I will put my question in English because the minister responsible for housing may not understand my French. May I ask the minister if the government intends to set up a ministry of urban affairs without the consent of the provinces?

Hon. Robert K. Andras (Minister without Portfolio): Mr. Speaker, this subject has been under consultation with all the provinces—I repeat, all the provinces. In the discussions about the formation of a ministry of state for urban affairs and housing, we have found no one who has suggested that this would be improper.

Mr. Valade: Mr. Speaker, may I ask the minister if he has discussed this matter with the province of Quebec, and whether the province of Quebec expressed to the minister its opposition to the setting up of such a ministry?

Mr. Andras: Mr. Speaker, their views have been communicated to us. I think the sensitivity of the situation has been recognized by the type of institution, a ministry of state for urban affairs and housing, which we are contemplating and about which I may have more to say in more detail when the government organization bill is back in the House.

The Department of Industry, Trade and Commerce is discussing and examining each case and, where necessary, references have been made to the Textile and Clothing Board for specific examination.

Mr. Ricard: Mr. Speaker, my question was direct. It does not need such an elaborate answer. I just want to know if specific measures have been taken or will be taken in this special case in order that this manufacturer will not close up shortly.

Mr. Howard (Okanagan Boundary): Mr. Speaker, measures under the regulations and under the legislation are taken for the industry as a whole and not for a specific factory. In this context, the remedy must be applied on an over-all basis.
