PERSONNEL AT FEDERAL BUILDING, BROCKVILLE, ONTARIO

Question No. 52-Mr. Cossitt:

1. What are the names and job designations of all persons hired by the Department of Public Works at the Federal Building in Brockville, Ontario, since January 1, 1974?

2. In each case, was a competition held and, if so (a) on what date (b) how many applicants were involved (c) what are the names of all persons placed on the eligible list?

3. Were there any cases where competitions were not held for either temporary or permanent employment and, if so (a) for what reasons (b) what are the names and job designations of all persons hired?

4. What is a general description of the hiring practices used by the Department at the Brockville Federal Building?

Mr. Alexandre Cyr (Parliamentary Secretary to Minister of Public Works): 1. All of the employees hired since January 1, 1974 have been temporary replacements for sick leave or vacation. The names of the employees and the dates employed are listed below: Scale, L. M., GS-BUS-2, Cleaner, 8-8-74 to 13-8-74; 22-7-74 to 2-8-74; McIsaac, N., GS-BUS-2, Cleaner, 28-10-74 to 1-11-74; 22-8-74 to 7-9-74; Euverman, C. A., GS-BUS-1, Cleaning Service Woman, 25-8-75 to 29-8-75; 15-12-75 to 30-12-75; 14-10-75 to 20-10-75; 7-7-75 to 25-7-75; 17-3-75 to 1-4-75; 28-10-74 to 30-10-74; 16-9-74 to 27-9-74; 19-8-74 to 30-8-74; 16-12-74 to 21-12-74; 15-7-74 to 2-8-74; Bellinger, D., GS-BUS-2, Cleaner, 9-7-74 to 12-8-74; Todd, B., GS-BUS-2, Cleaner, 5-1-76 to 30-1-76; 6-10-75 to 15-10-75; 23-6-75 to 29-8-75; 9-6-75 to 13-6-75; 2-12-74 to 31-12-74; 23-8-74 to 23-8-74 (8 hrs); Van Rijswijk, E., GS-BUS-2, Cleaner; Reid, D., GS-BUS-1, Cleaning Service Woman; Phythian, H., GS-BUS-2, Cleaner.

2. (a) In each case an open competition was held in the sense that referrals were obtained from the local Canada Manpower Centre. (b) We have no permanent record of the number of candidates involved as it is not departmental practice to maintain such records on casual appointment actions. (c) In each case, only the successful candidate was placed on the eligible list.

3. There are no cases where an open competition was not held. As each vacancy arose, referrals were obtained from the Canada Manpower Centre.

4. It is the practice of the Department to approach the Department of Manpower and Immigration's Canada Manpower Centre in Brockville to request that individuals be referred for vacancies as they arise. Once referred, these individuals are assessed against predetermined selection criteria and a decision is made as to who is the most suitably qualified for the position.

1. Was Mr. J. Donoghue, Executive Director of Operational Planning for the Unemployment Insurance Commission of Canada, formerly Regional Director for the Province of Ontario?

On what date was Mr. Donoghue appointed Regional Director for Ontario and until what date did he hold that position (a) what was the exact number of dollars paid to him in salary during the time he held this position (b) what is his exact salary in dollars in his present position (c) was Mr. Donoghue stationed in Belleville, Ontario when he was Regional Director for the Province?

3. During the time that Mr. Donoghue was Regional Director for Ontario did he commute on weekends on a more or less regular basis to and from Ottawa (a) was this commuting done via Toronto (b) what means of transportation was used for all aspects of this commuting (c) what was the entire cost paid by the government (d) was a daily meal allowance paid by the government to Mr. Donoghue during his term in Belleville and, if so (i) for what reason (ii) what was the total amount paid (e) did the government contribute towards rental of accommodation for Mr. Donoghue in Belleville and, if so, what was the total amount paid while he was there?

4. What is the total of all expenses of any kind whatsoever paid to Mr. Donoghue while he was Regional Director for Ontario?

5. (a) Is Mrs. A. Humphreys acting at the present time as secretary to Mr. J. Donoghue in his position as Executive Director of Operational Planning (b) did Mrs. Humphreys act as secretary for Mr. Donoghue while he was Regional Director for Ontario (c) what is the total of all expenses paid to Mrs. Humphreys while she was stationed in Belleville including specifically (i) transportation (ii) meal allowances (iii) accommodation (d) what was the exact annual salary in dollars of Mrs. Humphreys while she was stationed in Belleville and what is her exact salary now?

Hon. Jack Cullen (Minister of Manpower and Immigration): In so far as the Unemployment insurance Commission is concerned: 1. Yes.

2. Acting appointment October 1, 1972 to August 30, 1973. Confirmed in the position September 1, 1973 until April 18, 1975. (a) His salary ranges were as follows: October 1, 1972— December 31, 1972, (\$25,000-\$31,000); January 1, 1973— March 31, 1974, (\$26,750-\$33,750); April 1, 1974—March 31, 1975, (\$29,000-\$37,000); April 1, 1975—April 18, 1975 (\$31,500-\$41,500); (b) \$35,500-\$47,500—Salary range for his present position. (c) Yes, after being confirmed as Regional Director on September 1, 1973.

3. Yes. (a) Travel to Toronto was dependant upon the need to meet with the Toronto Metro management, weekend meetings with unions, the media, etc. (b) Train, air, private motor car, and bus. (c) Approximately \$3,240 to cover travel costs from October 1972 to August 24, 1973. The figure includes travel to Ottawa for purposes of attending to Commission business. (d) Yes—the employee was in an acting capacity and (i) on extended travel status in accordance with Treasury Board Regulations (ii) \$650.00 (e) No.
