comply with any order made by the Treasury Board in that regard. I cannot be more clear than that.

PHARMACEUTICAL INDUSTRY

REQUEST FOR WITHDRAWAL OF PATENT AMENDING LEGISLATION

Mr. David Orlikow (Winnipeg North): Mr. Speaker, I should like to direct a question to the Minister of Consumer and Corporate Affairs. I am sure he will know that a poll published on Saturday indicated that a very substantial majority of Canadians from every region, and supporters of every Party including the Conservative Party, are opposed to the prescription drug legislation. Given the fact that the Government has already been made unpopular as a result of decisions such as the one on lumber and the agreement with France on fish, is it not time that the Government faced up to reality and withdrew a Bill which is so unpopular?

Hon. Harvie Andre (Minister of Consumer and Corporate Affairs): Mr. Speaker, the House has already decided on that issue and supports the Bill in principle, and rightfully so. It will lead to improvement in the health care to Canadians. It will lead to thousands of research jobs. It will enable Canada to participate in the exciting biotechnologies. Frankly I cannot understand how responsible Members of Parliament could in fact say that Canada should opt out of this technology and let the rest of the world do that research. That is just irresponsible and something I would never concur with.

Mr. David Orlikow (Winnipeg North): Mr. Speaker, despite everything the Minister and his supporters have said, does he not realize that according to the poll Canadians believe that they will have to pay higher prices for prescription drugs, that the companies will make much higher profits, and that there will be very little new research done? Given those facts is the Government going ahead with the Bill because it has made a commitment to President Reagan and the United States and it is part of trying to get a free trade agreement? Isn't that the real reason that the Government is going ahead?
