- Mr. Doug Lewis (Parliamentary Secretary to Deputy Prime Minister and President of the Privy Council): 1. Yes. The Government approved the gala performance which was attended by 1,559 persons.
 - 2. Yes.
- 3. and 4. It would not be proper to name those present or not without their consent. It is customary for such events that Canadian dignitaries, Senators, Members of Parliament and Canadian officials be invited.

- 6. (a) \$90,453. (b) Yes, included in Part 6 (a), but not available separately.
- 7. \$185,906.88. The rental cost was paid by the Department of External Affairs and the Privy Council Office.
 - 8. \$421,843. excluding amount in Part 6 (a).
 - 9. No.
- 10. Yes. (a) 100-member guard of honor in ceremonial uniform. None of the honor guard members were women.
- (b) No. All the honor guard members were from RCMP Divisions in Ottawa and were transported to and from Quebec City by charter bus.
- (c) Transportation, \$2,460; meals, \$2,325; accommodation, nil; Salaries, in accordance with RCMP policy, members assigned to this duty were compensated at a double-time overtime rate. Members had the options of accepting direct payment or time off in lieu of payment. It would be difficult to determine precise dollar cost paid in salaries since members were from various units in the Ottawa region and because this information is not computerized totally.
- 11. (a) and (b) Security planning and operations for this visit were matters of federal jurisdiction falling under the control of the RCMP. RCMP expenditures on the March,

- 1985 visit of President Reagan to Quebec City amounted to \$1,011,496.
- (c) Participating police forces (other than the RCMP) absorbed all their own costs, as the duties performed fell within their respective mandates. The visit was confined to venues within Quebec City and close co-operation was therefore necessary with the Sillery, Quebec and Ste-Foy municipal police forces. Quebec provincial police force members were engaged in labour negotiations in March, 1985, and provided no security services during the presidential visit in accordance with a directive from the Quebec provincial Government.

Private-sector security organizations were not involved in providing security during the President's visit.
