reinstated for benefits once their unemployment insurance runs out? These are questions which really must be answered.

Finally, Hon. Members on this side of the House support the basic concepts of the program for older worker adjustment. However, we will ensure that this new program provides more assistance to older workers than the old LAB Program. There are many unanswered questions in this Bill, and we in the Liberal Party will want these questions answered. This Government must realize the hardships faced by older workers, and it must protect them from these hardships.

Mr. Deputy Speaker: Is the House ready for the question?
