Government Orders

I think in fact the retroactivity provision was to start on January 1, 1988 with a second clause to further add to that for 1989. What the new clause does, as I understand it, is put the amount including the multiplier effect together in order to give effect to the 1989 rate immediately, if my understanding is correct.

Mr. Cooper: Madam Chairman, the purpose of the amendment to Clause 1 is to replace 1988 by 1989 and to replace \$80,000 by \$83,800 which is \$80,000 for the annual salary in the original bill for 1988 plus the \$3,800 for the 1989 indexation adjustment.
