HANINGTON, DANIEL L., Q.C. (Westmoreland.)

Of English and Royalist descent. S. of Daniel Hanington, late Presdt. of L.C., and grands. of Wm. Hanington, Esq., of London, Eng., who settled in Shediac in 1784, and was the first English resident there, and of Wm. Peters, Esq., M.P.P., of Queen's Co, gentleman. B. at Shediac, 27 June, 1835. M., Oct., 1861, Emily Myers, dau. of the late T. R. Wetmore, Esq., Gagetown, N.B., Called to the Bar of N.B. 1861. Apptd. QC 11 Nov., 1881. Was Clerk of Circuits and of the County Court for Westmoreland from 1867 to 1870, when he resigned to contest the election of that year. Was first returned to Ho. of Assem. Dec. 1870, for the Co. of Westmoreland. Sat therein until the summer of 1874. Was then defeated on the "Bible and religious instruction in common schools" question, which he advocated. Was elected at g.e. 1878, 1882,
