Speaker's Rulings:

- 1. Proposed motion of Mr. Drew to adjourn House under Standing Order 31 re press statements reported to have been made by Mr. Harris, Parliamentary Assistant to the Prime Minister re possible war with Russia as an outcome of the signing of the North Atlantic Pact, 35; ruled out of order on the ground that there was no urgency for the discussion, as matter referred to was mentioned in Speech from the Throne now being discussed, 36. Ruling appealed and sustained (yeas 133; nays 55), 36.
- 2. Proposed amendment of Mr. Macdonnell (Muskoka-Ontario) to motion of Mr. Abbott for Mr. Speaker to leave the Chair for House in Committee of the Whole on the Resolution re Foreign Exchange; ruled out of order on the ground that it was of such a character as could only be moved on the second reading of a bill, 218.
- 3. Proposed amendment of Mr. Macdonnell (Muskoka-Ontario) to motion of Mr. Abbott for second reading of Bill No. 85 re Foreign Exchange Control, ruled out of order by Mr. Deputy Speaker on the ground that it could not be moved on the second reading of a bill involving expenditure, 230.
- 4. Proposed amendment of Mr. Fleming to motion of Mr. Garson for the second reading of Bill No. 86 re continuation of National Emergency powers, ruled out of order on the ground that the House cannot, under the guise of referring the subject-matter of a bill to a Committee, also refer certain provisions of the bill itself; nor can the House both refuse to give the second reading and refer some provisions of the Bill to a Committee; the adoption of the amendment would cause the bill to disappear from the Order Paper. It would be killed without any hope of revival during the present session, 233. Ruling appealed and sustained (yeas 149; nays 55), 233.
- 5. Proposed amendment of Mr. Knowles to motion of Mr. Abbott,—That Mr. Speaker do now leave the Chair for the House to resolve itself into Committee of Supply, ruled out of order on the ground that it anticipated discussion of Old Age Pensions which were dealt with in private members' notices of motions now standing on the Order Paper, 275. Ruling appealed and sustained (yeas 107; nays 99), 275.
- 6. Proposed motion of Mr. Wright that an Instruction be issued to the Committee of the Whole on Bill 82 (Agricultural Marketing) that the Committee have power to amend Bill by inserting certain words, etc., ruled out of order on the ground that the Instruction purported to confer on the Committee of the Whole authority to do something which the Committee already had power to do, 365.
