Mr. NEILL: Stationery? Coal? Gas?

Mr. MICHAUD: No. We have boats on the Atlantic. He buys supplies for all the boats, and supplies for all the hatcheries. There are repairs needed for our boats, and everything is done through tender. I think the officer justifies his existence as such by the work that under my observation he has to do. Possibly a concentration of all the purchasing departments of the government might result in some saving, but it is a matter of policy.

Mr. NEILL: Could we not cut out the man in British Columbia? The Atlantic purchasing is done here; could not the Pacific coast purchasing be done here also?

Mr. MICHAUD: I doubt it. The purchasing of supplies for British Columbia would be difficult to do from Ottawa. The distances are against us; it is so far away that it takes a long time to communicate. I understand the system that now prevails in Vancouver has been in vogue for over twenty years. Prior to that time the department was administered wholly from Ottawa, and it was not found satisfactory. That is the information I have.

Mr. NEILL: We have a three day mail service now; try air mail and telegraph and wireless; I do not think the distance has got any greater. Is it not a fact that within the last five or six years the department in British Columbia bought three boats? I forget the names of them all, but one, I think, is called the Vanidis. If my information is not erroneous they have already had to rebuild two of them, or they have rebuilt one and contemplate rebuilding the other two. I do not know whether "rebuilding" or "reorganization" is the correct word, but I understand some very big alterations have had to be made on a comparatively new boat.

Mr. MICHAUD: I understand some alterations were made in a boat.

Mr. NEILL: A new boat.

Mr. MICHAUD: A new boat which was bought some years ago.

Mr. NEILL: Then for God's sake get a new purchasing agent.

Item agreed to.
