WAR MATERIALS-STAR MANUFACTURING COM-PANY PLANT, DARTMOUTH, N.S.

Mr. ISNOR:

1. Was a survey or investigation made by the Department of Munitions and Supply or the Department of National Defence, in connection with the plant known as Star Manufacturing Company, Dartmouth, Nova Scotia, with a view to utilizing same for the manufacture of shells, munitions or other war materials?

2. If so, on what date, by whom and with

what result?

Mr. HOWE:

1. Yes.

2. Inspection of the Star Manufacturing Works Limited, Dartmouth, Nova Scotia, was made by Colonel G. G. J. Ball, mechanical engineer, M.D. 6, of the Department of National Defence on March 18 and 19, 1937. The plant was again inspected by Colonel G. Ogilvie, Colonel G. G. J. Ball, and Major Bishop of the Department of National Defence on July 28, 1937. Inspection was made of the plant on August 12, 1940 by Mr. W. O. Mc-Dowell of the Department of Munitions and Supply.

The company is considered capable of supplying for war-time requirements bolts, nuts, rivets, ship's hardware, etc.

So far it has not been considered advisable to utilize this plant for the manufacture of shells or munitions.
