SITE FOR DUMPING OF GARBAGE FROM METROPOLITAN TORONTO

LOCAL INITIATIVES PROGRAM—REQUEST FOR DECISION ON CERTAIN VANCOUVER THEATRE PROJECTS

Mr. Stuart Leggatt (New Westminster): Mr. Speaker, my question is directed to the Minister of Manpower and Immigration. In view of the fact that seven LIP theatre projects in the Vancouver area have been recommended to him and are still in limbo, leaving personnel, material

and locations idle for weeks at this time of high unemployment, can the minister give a firm date when a decision will be made on these projects?

Andras (Minister of Manpower and Immigration): Mr. Speaker, I do not think I am in a position to give a precise date other than the indication I gave yesterday that we will be issuing all approvals by approximately January 19. I might say that some of those particular projects are difficult to decide upon because this will be the second or third time that one or two of them have been financed. This raises the question of when such a project becomes viable to operate on its own or whether it should receive continued public financing if the general public does not support it.
