### MR. ALLMAND—THREAT TO PEACE IN CENTRAL AMERICA— CANADA'S POSITION

Hon. Warren Allmand (Notre-Dame-de-Grâce-Lachine East): Mr. Speaker, I have a petition with respect to Central America signed by thousands of Canadians to the honourable the House of Commons in Parliament assembled. The petition of the undersigned residents of Canada, who now avail themselves of their ancient and undoubted right thus to present a grievance common to your petitioners in the certain assurance that your Honourable House will therefore provide a remedy, humbly sheweth that global peace is threatened by the growing conflict in Central America. Central America is being turned into a war zone by the arming of privileged elites against the pressures of social change. Canada, by taking decisive public action, can reinforce the threatened prospects for peace. Peace in Central America must be founded on the basis of non-intervention and self-determination, and that Canada can and must do more than praise the Contadora peace initiative. Mr. Allmand: Mr. Speaker, I must say that I cleared this beforehand with certain officials and was led to believe that this was proper. However, if you wish, I will get to the conclusion of the petition.

Therefore, your petitioners humbly pray that the House of Commons will recommend that the Prime Minister state publicly and clearly Canada's unequivocal opposition to the United States military intervention in Central America; press publicly for immediate concrete initiatives to demilitarize Central America, including the end to all foreign military aid, the withdrawal of foreign military forces, and an end to the covert war against Nicaragua; urge the United States to open unconditional negotiations with the opposition in El Salvador; suspend Canadian bilateral aid until Honduras renews its neutrality; establish a Canadian embassy in Managua; and initiate immediate and sizeable humanitarian and bilateral aid.
