RESOLVED, That the sum of £125 7s. 8d. be paid to the Clerk to pay the Contingencies in his Office during the last and present Sessions of the Legislature, and that the suin of £8 13-. 8d. be paid to the Usher of the Black Rod, to defray the Contingencies of his Conce during the last and present Sessions of the Legislature; and that the Master in Chancery, the Clerk, the Usher of the Black Rod, and the Deorkeeper of this House be placed, in point of Emolument, on a footing with the Solicitor, Clerk, Serjeant-at-Arms and the Leorkeeper of the House of Assembly.
