THE IRISH ARREARS BILL.

LONDON, May 23. - The amount of arrears of rent owed by the tenants of Ireland, which the bill before the commons would wipe out, is \$50,000,000.

BOYCOTTING THE BREWERS.

THE RETAIL LIQUOR BEER AND ICE PRICES OF LAGER.

A Large Meeting at Germania Hall Yesterday - The Line of Action to be Followed by the Retailers.

The retail liquor trade of the city to the number of eighty assembled at Germania hall yesterday afternoon to consider a circular issued by the Canada Lager Beer Brewers' association which prices and privileges under which lager beer is handled by the retailers. The meeting was very unanimous in the action taken, and the best of harmony prevailed. At 3.30 o'clock Wm. Armstrong was voted to the chair and Geo. Mitchell acted as secretary.

A. G. Hodges stated that the following circular would fully explain the objects of the meeting, which, however, was not called by the Toronto branch of the Ontario Trade and Benevolent society [although its officers presided], but was in the interest of every retail liquor dealer in the city. The circular referred to reads: 'The Ontario Trade and Benevolent Association.'

DEAR SIR: - I am instructed to inform you that as a meeting of the larger beer brewers and retailers to-day was unanimously resolved that the price of retail liquor (equal to 10 cents per wine gallon) and 10 cents per dozen for imported beer (equal to 10 cents per wine gallon) of the season and great increase in the cost of materials, necessitating a raise in the price of retail liquor, it is the wish of the brewers that no tap, pump or other apparatus should be supplied by the retailers.

The secretary read a telegram from several outside brewers. G. W. Sleight of Guelph offered to supply lager beer at 22 cents per gallon (100 lbs. measure) delivered in the city, freight free. P. J. Bagn of Kingston and J. M. Lotteridge and Knitz of Hamilton promised to furnish beer at 22 cents per gallon.

A discussion then followed. The brewers were characterized as men who made thousands of dollars per annum and lived in palatial residences at the expense of the retail men. John Brewer favored a decisive vote of boycott of the brewers. He stated that he was in the city in a solid body and did not recognize the brewers or buy their beer unless they were credited with more than they were entitled to. It was the wish of the retailers who built up larger beer drinking that they could pull it down.

Mr. George Robinson explained how the country dealers were supplied, showing that they were better treated than the city dealers.

Mr. John Graham strongly urged the retailer in the city not to take any more trade until the brewers came to their senses and agreed to the terms of the boycott. He stated that the great waste in handling larger beer, and the small profits that were made on it. He was in favor of vigorous opposition to the curtailment of the privileges which are now granted by the brewers. He would therefore move the following motion, which found a second in Mr. J. R. Wilson: That the members of our association do not act as a body for the purpose of buying beer from the brewers of the city unless the same terms and the same appliances as now receive are furnished, and that this resolution take effect on Monday, May 28.

A standing vote was taken on the motion and it was carried unanimously amid much applause.

Several short speeches were made, all in favor of the resolution. The meeting ended. One member thought if the retailers handled lager at all four months out of the year they would be better off. Other speakers stated that as the brewers added the cost of lager on the retailers they (the brewers) should not be so hopeful. The trade of the city should be in the hands of the retailer, and all right without the sale of the whole trade was brought about by one brewer.

EXTENDING THE BOYCOT. It was then moved by J. Brewer, seconded by S. Hunter, that if the brewers' association insist on enforcing the terms contained in their circular that the Trade and Benevolent association of Toronto pledge themselves not to purchase any strong ale in future from the brewers who manufacture lager beer in the city of Toronto, as there are a number of the brewers who are members of our association not in connection with the brewers' association who under the circumstances are entitled to our support.

After a brief discussion it was decided to allow this motion to stand until the next meeting. The secretary was instructed to notify the brewers of the action of the meeting and request an answer from them on Friday morning, which answer will be considered on the same afternoon at the same hall and at the same hour.

WHAT THE BREWERS SAY. After the meeting above reported a World reporter made a prominent beer brewer and asked him about the curtailment of privileges to the retailers. He said the brewers were not making anything like the money that they were credited with, and their expenses were daily increasing. They could not afford to furnish the retailers with the costly adjuncts of beer-slinging which they had been in the habit of doing. Another thing they intended to shut down on was the practice of allowing their drivers \$2 or \$3 per day to spend with the customers. The drivers often came off their routes with all up and in addition to the amount spent gave other trouble. He thought the brewers' association would fight it out.

Completion to Rev. Gavin Lang. MONTREAL, May 23. - Rev. Gavin Lang was entertained to a public breakfast this morning, previous to his departure from the city. In the absence of the bishop of Montreal, Canon Ellogood presided, and a very large number of ladies and gentlemen were present. An address was presented to Mr. Lang by the chairman, to which he eloquently replied.

A Preacher on his Muscles. FORT WAYNE, Ind., May 23. - For years a feud has existed between Rev. Dr. Stearns and Dr. Swearingen and Myers. On Sunday Stearns preached in the Free Methodist church, and Swearingen and Myers concluded a front pew. When Stearns had finished he approached Swearingen, and exclaimed, 'I want you to stop making faces at me.' Swearingen was afterwards proceeded with. Yesterday Swearingen served out a warrant for Stearns' arrest, charging him with provoking assault. When the preacher saw his accuser in the court he dealt him a stinging blow between the eyes. Swearingen fell, and as he arose the pastor hit him again twice. The preacher then took away and Swearingen took out another warrant. Swearingen is not ordained, but has preached frequently.
