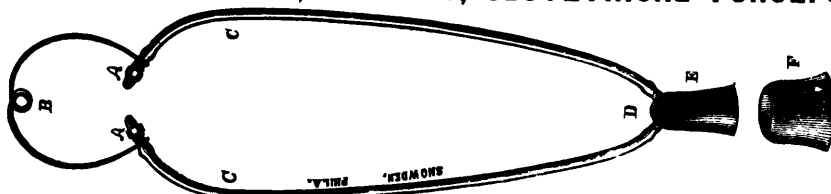

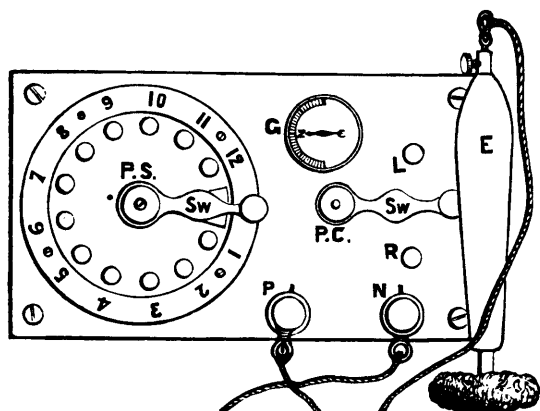


SNOWDEN'S PERFECTED BINAURAL STETHOSCOPE.
