

and the unemployment insurance commission of Canada to provide for reciprocal treatment of workers moving from one area into the other. As all hon. members know, we have such an agreement with 47 other states.

I received no definite indication from the authorities in Maine though I pressed for a decision at an early date. Once a decision has been made the government and the unemployment insurance commission will then be in a position to assess what further steps ought to be taken.

### NATIONAL PARKS

#### BANFF, ALTA.—REPORTED APPOINTMENT OF ADMINISTRATOR

On the orders of the day:

**Mr. Eldon M. Woolliams (Bow River):** Mr. Speaker, I should like to direct a question to the Minister of Northern Affairs and National Resources. This is an important question so far as the national parks and our tourist trade are concerned. Is it correct that the present government has abolished the elected Banff advisory council and intends to appoint an administrator to run Banff national park and other parks in Canada?

**Hon. Arthur Laing (Minister of Northern Affairs and National Resources):** Mr. Speaker, I always thought it was a somewhat dangerous practice for a private member to announce government policy. I noticed in a copy of the *Albertan* yesterday that the hon. member had announced that this was government policy. I want to tell him that the advisory committee has not been abolished, nor is there any intention on the part of the government to abolish it.

**Mr. Woolliams:** A supplementary question, Mr. Speaker. When the minister was at Banff national park did he not announce that an administrator would be appointed to look after the affairs of Banff? If so, what is the name of that administrator?

**Mr. Laing:** Mr. Speaker, I announced that it was the intention of the government to appoint an administrator for the townsite of Banff. I announced at the same time that I would expect that administrator to work as closely as possible with the advisory council. I have no names in mind whatsoever for the position of administrator. We are seeking a person with civic experience and who also has some recognition of the long term objectives with regard to the parks.
