

PURPOSE OF PROTECTION WORKS  
CONSTRUCTION

Question No. 568—**Mr. Schreyer:**

1. With reference to the protection works constructed or contributed to by the Department of Public Works, in each of the last three fiscal years at ten locations along the Fraser River, B.C.; three locations along the St. Clair River in Ontario; one location along the Detroit River in Ontario; thirty-one locations along the St. Lawrence River in Quebec; and seven locations elsewhere in the Province of Quebec, in how many of the foregoing cases was riverbank stabilization the primary or only purpose of such works?

2. What levels of government, corporations or persons were involved in the cost-sharing of these works and in what proportion did each interested party share these costs?

3. Which of the foregoing cases involved riverbank stabilization for the protection of (a) Crown-owned property (b) municipality-owned property (c) private-owned property?

**Hon. Arthur Laing (Minister of Public Works):** 1. In all cases.

2. Fraser river: Federal government, 37½ per cent; Provincial government, 37½ per cent; Municipality or district through tax levy, 25 per cent. St. Clair river: Federal government, 50 per cent; Private owner, 50 per cent. Detroit river: Federal government, 100 per cent; St. Lawrence river: Federal government, 100 per cent.

3. All properties were privately owned.

TERRAPLANE TEST RESULTS

Question No. 577—**Mr. Blouin:**

1. What were the results of the testing of the Terraplane at Orleans, Ont. as referred to in a Department of Transport Press Release issued June 21, 1968?

2. Does the government intend to submit this vehicle to further tests in other regions of the country, especially where there are no roads?

**Hon. Paul Hellyer (Minister of Transport):**

1. The results were inconclusive due to the development of several component defects which precluded testing the vehicle in northern Canada.

2. Not unless engineering modifications are undertaken by the manufacturer. The subject is, however, still under correspondence.
