Hon. Arthur Laing (Minister of Indian Affairs and Northern Development): Mr. Speaker, there has already been wide distribution of this report and we expect to have a great deal of comment. We have no plan for any formal hearings at the present time. As a matter of fact, I believe the commission itself saw and spoke to almost 4,000 people in its visits through the territories, which I would think is between 25 per cent and 30 per cent of all the adult citizens there.
