Right Hon. L. B. This was all he had in mind, to make sure the administration makes certain the money is well spent.

Mr. Patterson: May I ask a supplementary question. I wonder if the minister's views have been formally submitted to the directorate of the FAO?

Mr. Pearson: I know that the Minister of Agriculture is attending the meeting in Rome and has been in touch with the director. I know also that not long ago the director was in Ottawa and we had a chance to discuss with him the administration of this organization.

NORTH VIET NAM—PROTEST RESPECTING CANADIAN POSITION ON CONTROL COMMISSION

On the orders of the day:

Mr. W. B. Nesbitt (Oxford): I have a question I wished to put to the Secretary of State for External Affairs, but in his temporary absence I shall direct the question to the Prime Minister. Has the government received a protest from the government of North Viet Nam concerning Canada's alleged non-neutral position as a member of the international control commission? I ask this question in view of a news report this morning over the Canadian Broadcasting Corporation reporting this protest.

Mr. Speaker: The first part of the question is in order.

Right Hon. L. B. Pearson (Prime Minister): I have also seen that news report, but I have had no message of any kind confirming it. I will get in touch with the minister when he returns later this afternoon to see whether external affairs has had any message from North Viet Nam.

Mr. Andrew Brewin (Greenwood): May I ask a supplementary question. I wonder if the Prime Minister, when speaking to the Secretary of State for External Affairs,

would also ask him to look into the question of what steps are taken by Canada, if any, to prevent the export of war materials destined for Viet Nam.

Mr. Pearson: Yes, Mr. Speaker, I will discuss that matter with my colleague.
