of national interest and of concern to all hon. members. In determining whether the business of the House ought to be set aside for the purpose of considering such an important and urgent situation, the Chair has to be guided by certain criteria specified in Standing Order 26. One of these requirements is that the matter proposed for discussion should relate to an emergency which calls for immediate and urgent consideration by the House. In other words, it is not only urgency of the matter which has to be considered but the urgency of debate.

While I surmise that the House would want an opportunity to discuss this problem, I doubt that the urgency of the situation would require that the debate be held today or tomorrow rather than later. If the Chair considers the additional factor of opportunity of debate within a reasonable period of time, I would suggest to the hon. member that from the procedural standpoint an immediate emergency debate would hardly be justified.

Therefore, in view of all relevant circumstances the Chair suggests that the adjournment motion should not be put at this time.

NATIONAL DEFENCE—SEPARATISTS IN CANADIAN FORCES

Question No. 1.229-Mr. Coates:

Has the Minister of National Defence examined the statements of René Levesque, leader of the Parti Québécois, regarding members of the Armed Services in the Province of Quebec and, if so, is he in a position to provide information as to whether all members of the Armed Services have taken the oath of allegiance and, if they have, will any action be taken against them if they are known to be Separatists and advocate the separation of the Province of Quebec from the Dominion of Canada?

Hon. Donald S. Macdonald (Minister of National Defence): Statements purported to have been made by Mr. René Levesque regarding members of the Canadian forces in Quebec being separatists have been examined. All Canadian citizens, and British subjects other than Canadians, applying to join the Canadian forces are required to take the Oath of Allegiance upon enrolment. Other persons enrolled in the Canadian forces are required to take a special oath that includes the agreement to well and truly serve Her Majesty, in the Canadian forces. In addition, Queens Regulations and Orders stipulate that no officer or man of the regular force shall take an active part in the affairs of a political organization or party. What action would be taken against members of the Canadian forces who may become known to be active separatists and advocates of the separation of the Province of Quebec from Canada would depend upon the circumstances of each case.
