CANADIAN NATIONAL RAILWAYS

POSSIBLE TAKE-OVER OF HOTELS—REQUEST THAT
CANADIAN-OWNED SKYLINE HOTELS BE GIVEN
CONSIDERATION

Mr. Arnold Malone (Battle River): Mr. Speaker, in the continued absence of the Minister of Transport I will direct this question to his parliamentary secretary—it relates to a question I asked earlier about whether or not there was to be a take-over of the management of a CN hotel; the response was to the effect that discussions were under way with Conrad-Hilton. In the light of present information that Skyline Hotels would like to be involved in any such discussions, and since Skyline is a Canadianowned and operated hotel chain, might I seek an assurance that no further discussions will take place with Conrad-Hilton until there has been full discussion with Canadian firms?

Mr. Cliff McIsaac (Parliamentary Secretary to Minister of Transport): I have nothing new to report since the last time this matter was raised. I shall certainly be glad to convey the point made by the hon. member to the management of Canadian National which is considering this whole question.

REQUEST FOR WINTER WORKS PROGRAM—GOVERNMENT POSITION

I must point out that they appear to me slightly in contradiction to statements made by a member of his own party who was leading off on my bill yesterday and who said that consultations with the provinces, particularly on winter works, had been ideal in the past. The hon. member is now suggesting that perhaps we should deal directly with the municipalities, and I would think that is something that we would have to consider in order to reconcile the two suggestions.

GOVERNMENT POSITION ON FURTHER SALES TO REPUBLIC OF CHINA

Hon. Otto E. Lang (Minister of Justice): Mr. Speaker, the Canadian Wheat Board is in constant contact with its principal customers, such as the People's Republic of China. In this case, as well there were discussions concerning the actual timing of deliveries. The Wheat Board is always alert to the appropriate time for further negotiations.
