# Mr. Herb Breau (Parliamentary Secretary to Secretary of State for External Affairs): 1. The amount expended by CIDA through the Canadian Commercial Corporation is as follows: 1973-74, \$55,625,265.71; 1974-75, \$69,569,999.03.
