# MR. DE JONG—EXTENSION OF UNEMPLOYMENT INSURANCE BENEFITS

Mr. Simon de Jong (Regina East): Mr. Speaker, I have a petition that I wish to introduce to the House. It is addressed to the House of Commons of Canada in Parliament assembled. The petition of the undersigned residents of Canada, who now exercise their right to present a grievance, humbly sheweth that whereas the number of unemployment people in Canada far exceeds the present demand for workers and the number of people whose Unemployment Insurance benefits become exhausted each month and who are subsequently forced to exist on inadequate welfare benefits is a national disgrace, therefore we, the undersigned petitioners, call on the Government of Canada to extend the length of payments of Unemployment Insurance benefits to those who qualify for major claims by a further 52 weeks.

## MR. DE JONG-STUDENT LOANS

Mr. Simon de Jong (Regina East): Mr. Speaker, I have a petition addressed to the honourable the House of Commons of Canada in Parliament assembled. The petition of the undersigned residents of Canada, who now exercise their right to present a grievance, humbly sheweth that whereas under present regulations people who are graduating from or leaving post-secondary educational institutions and who have taken out Canada student loans are required to begin paying back those loans within six months of leaving full-time study, and whereas with the present and projected level of unemployment at such a high rate many students find themselves without employment and in severe financial hardship for extended periods after leaving school, therefore we, the undersigned petitioners, humbly pray that the Government of Canada amend the Canada Student Loans Act to extend this grace period to 18 months.
