view was expressed by authors and artists in Halifax. It will continue to be expressed across Canada. That is one of my worries, and it should be of some concern to the Government.

Where do we cut? In my evaluation, we should not cut across the board and penalize everyone equally, but we should choose where those cuts will be made. We would not have chosen the same cuts, but I think it is a fair point to debate. The Government has chosen to cut across the board. I will not challenge that. That is my reply to the Hon. Minister's question put to the Hon. Member for Saint-Jacques (Mr. Guilbault).

Miss Carney: Mr. Speaker, I would like to direct a question to the Hon. Member for Saint-Jacques (Mr. Guilbault). In light of the comments which were made by the Hon. Member for Saint-Denis (Mr. Prud'homme), does the Hon. Member for Saint-Jacques concur with the idea that in a corporation such as the CBC, which costs taxpayers close to \$1 billion a year, there is no room and scope for expenditure cuts, particularly at the overhead and management level? Is he suggesting that taxpayers should commit a certain amount of money to any institution with absolutely no overview of the way in which the money is spent by the institution? Does he feel that \$75 million cannot be cut out of a corporation which was established by a Conservative Government and which has goals which are supported by the Conservative Government? Is he saying that in an operation of nearly \$1 billion, \$75 million cannot be saved in day to day overhead and management operations?

Mr. Guilbault (Saint-Jacques): Mr. Speaker, I think I answered that question. It was posed a moment ago by the Parliamentary Secretary. I expressed very clearly that I was against the way in which the cuts were made. First, they were made without warning—

Miss Carney: Do you agree?

Mr. Guilbault (Saint-Jacques): I am answering her question. She does not have to provide the answer.

Without notice, overnight, on November 8, the cuts were made. We on this side disliked it when the Minister of Communications posed as a hero and said that he was saving programming. The next day the President of the CBC denied that completely. I am not—
