CHICAGO, Feb 20—An unexpected increase in visible supply today, and numerous crop damage claims caused a sharp rally in wheat, and May closed 1/4 to 1/2 higher. Corn advanced 1/4 and oats 1/2. A general overthrow of long property demoralized provisions, pork rising 25 cents, lard 15c, and ribs 15 to 17c.

SMALLPOX AT PROVIDENCE. A Longshoreman Who Has the Dread Disease. PROVIDENCE, R. I., Feb 20—Eugene Santing, a longshoreman, applied at the Rhode Island hospital today for treatment for an eruption on his face. When the physicians examined him they found that the man was suffering from smallpox. The patient was immediately isolated and will be taken to the smallpox hospital later. The case is of a mild type.

CATHOLIC CHURCH BURNED. Fire Assisted by Water Causes Heavy Loss. PHILADELPHIA, Feb 20—The St. John's Roman Catholic church was ruined by fire and water today. The parochial residence adjoining was destroyed last night by fire, and it is believed fire had lodged under the church roof and there smoldered after the former fire was supposed to have been wholly checked. Today flames burst through the church roof, the roof quickly fell in and the interior of the church was completely ruined. Loss about \$50,000.

OLD MERCANTILE FIRM FAILS. MALDEN, N. Y., Feb 19—H. E. King & Son, the oldest mercantile firm in Malden, have filed a petition in bankruptcy. The assets are understood to be nearly \$75,000, and liabilities larger than this sum.

THE ALASKAN BOUNDARY IS PROVING A DIFFICULT QUESTION TO SETTLE.

WASHINGTON, Feb 20—The American Canadian Joint High Commission, after a session today, adjourned to meet at Quebec August 2 until the chairman of the respective commissions agree upon another date. The joint commission first began its labors nearly six months ago in Canada, and with the exception of probably a month, been earnestly at work endeavoring to effect an agreement with a view to the formulation of a treaty covering many perplexing questions of differences affecting the business interests of the United States and Canada.

HE WAS MURDERED AND AN ATTEMPT MADE TO CONCEAL THE CRIME.

BRADFORD, Me., Feb 20—The circumstances surrounding the finding of the dead body of Edward Ellingwood in his yard Saturday night, with an ugly wound in the back of his head, a knife and rifle lying near, and his house in flames, lead to the belief that he was murdered and that an attempt was made to conceal the crime. Mr. Ellingwood lived a solitary life at some distance from any other habitations and while he had a reputation of being eccentric he was always considered an industrious man and was believed to be quite well off.

DESTITUTION IN DEDHAM. Shutting Down of Woolen Mills and General Business Depression Are the Causes.

BOSTON, Feb 20—Owing in part to the shut-down of the Merchants' woolen mills at East Dedham, and in part to the general depression in business, there is greater destitution in Dedham than there has been in years. Many worthy people never before driven to that extremity have been obliged by actual want to apply to the board of overseers of the poor for aid. It is said that there are many others laboring under the same conditions, and that the result of that condition found among the poorer classes of the town.

OTTAWA IS HOSTILE. The Toronto-Collingwood Grain Route Severely Criticized—The Old Fort—No Proposal For Purchase Yet Received—Trade With Australia.

OTTAWA, Feb 16—The people and press of Ottawa are at no pains to conceal their hostility to the proposed Toronto-Collingwood grain route because they fear that it would seriously interfere with the usefulness of the Botha system, which is essentially an Ottawa enterprise. The citizens this morning, editorially, says: "Influential citizens of Toronto are to visit the capital tomorrow for the purpose of inducing the government to build a new railway, as a Federal work, from Collingwood to Toronto, and to carry grain and other freight from the northwest for next to nothing. This, in brief, is the cool proposition which Toronto is going to submit to the government as one way to counteract the effect of the competition of the Ottawa & Parry Sound Railways. It can hardly be believed that parliament would for a single moment countenance such a fool project."

NEW YORK FOG-BOUND. Travel Badly Delayed in All Directions.

NEW YORK, Feb 18—Both the rivers and the bay were enveloped in fog this morning and travel was seriously delayed. Ferries on both the East and North rivers ran on about half schedule during the early hours. At 8 o'clock delays on the shorter lines averaged nearly half an hour. The cable and electric cars were unceremoniously stopped on the day of the blizzard. Everything seemed to be in a hopeless tangle. Express trains were run far behind the regular schedule and way trains on hill-or-mine plan. Along the river front the fog and slush worked together with such good effect that blockades occurred every few minutes. West street, always one of the busiest highways of the town, and all ways especially crowded on Saturday morning, was almost impassable at 8 o'clock, and after that hour drivers and horses were mired in almost inextricable tangle. Owing to the dense fog the transport Sherburne, which was to have sailed for Manila today, will not leave until tomorrow morning. She was lying at her pier at the foot of Pacific street, Brooklyn, this morning, with the 12th in entry and the 3rd battalion of the 17th infantry aboard. The final preparations for her departure were being made.

BEER SHIPPED TO MILES' ARMY. Testimony That It Remained on a Porto Rico Wharf for a Month.

WASHINGTON, Feb 20—The army board of survey, appointed to enquire into the condemnation of 300,000 pounds of refrigerated beer consigned to General Miles' Porto Rico expedition in the war, has covered most of the ground involved in the examination and expects to give its finding soon. This particular board was not an outgrowth of the charges made by Gen Miles concerning the quality of the beer furnished the troops. It was appointed in the report of the board of inspectors for the condemnation of this particular cargo and to decide whether Smith & Co., from whom the beer was purchased, and the government was responsible for its spoiling. The board is already convinced that the beer was not spoiled when delivered by the contractors, and that it had not been chemically treated. The evidence so far brought out by the board shows that the beer was duly discharged at Porto Rico, and that it lay on a wharf for a month without any care. No attempt was made to learn the condition in that period, and when finally opened it was found unfit for use and nothing remained but to condemn it.

GALLANT RESCUE. Fourteen Men Taken From the Sinking Baxter.

BOSTON, Feb 20—Fourteen shipwrecked seamen were landed at their port yesterday after an experience which none of them would care to repeat. The fact that the men are alive is due entirely to the gallant action of the captain and crew of the British steamer Mounse, Capt Birchman, which reached here yesterday afternoon from Shields, Eng. It was on Feb 15, 10 a. m. when in lat 42° 23' N, long 64° 27' W, that the officers on the bridge of the Mounse sighted a little schooner bying his red signal, and apparently in imminent danger of being engulfed by the terrific seas which were running. In answer to that signal for help Capt Birchman immediately changed his course and ran down to the distressed vessel, which proved to be the Gloucester, a schooner of 14 men. The Gloucester had nearly abandoned hope of rescue when the British steamer was sighted on the horizon and it was seen by those on the sinking craft that their signal for help had been noticed.

FELL IN BOILING WATER. Stoneham Man Terribly Scalded at Lynn.

LYNN, Feb 20—William P Hill, foreman at the General Electric works, was scalded this afternoon, and tonight his condition is pronounced critical. He has been foreman in the yard of the works for several years. He is 45 years old, resides in Stoneham and has a wife and two children. He was taken to the home of his brother-in-law, J. F. Ouster, Anoka pl, after the accident. Hill was superintending the removal of some machinery from one factory to another, when in order to allow a car to pass, he stepped backward and into a hole in the yard which had been made by exhaust steam from the boilers. The hole is about three feet deep and was almost filled with boiling water. He was pulled from the hole by men standing near and taken away in an unconscious condition.

FATHER SURRENDERED HIM. Charles F. Gebow, Who Escaped From the Lynn Police.

BOSTON, Feb 20—A rare case of paternal discipline was illustrated in Lynn this morning, when Charles F Gebow, about 20 years old, was brought to headquarters and surrendered to the officials by his father. Gebow was wanted for breaking and entering. Last evening, about 10 o'clock, Officer Hall noticed a man acting suspiciously near the recently burned liquor saloon of DeWitt O. Upton. As the officer approached the man ran, going into the burned building and jumping out of a rear window. At this point he was joined by another man, and both men ran across the marsh towards the tracks of the Boston & Maine railroad. Officer Hall fired several shots at the men, but they escaped. He did not know who they were, and had but a vague description of them. About 8 o'clock this morning, however, Mr Gebow brought his son to the police headquarters. The son admitted that he was one of the men who had been chased by Officer Hall and said that one of the bullets had lodged in his back, and he desired to be sent to the hospital and have it taken out. This was done, and later Gebow was locked up at police headquarters. He gave the name of his companion and the police are looking for him. In the building was found a dark lantern and appliances for taking the lead pipe and other detachable apparatus.

WRECKING PUMPS SET UP. Every Effort Being Made to Float the Steamer Admiral Dewey at Cuttyhunk.

VINEYARD HAVEN, Feb 20—The Boston Vineyard Company is making every effort to float the steamer Admiral Dewey at Cuttyhunk. The wrecking pumps will arrive at Woods Hole by special train from Boston, to be used if necessary. Two heavy cables and hawsers have been placed east of stern of the ship. While Captain McGrath of the Dewey was absent from his ship yesterday some unknown person entered his room and appropriated about \$75 and some jewelry which belonged to him.

ABANDONED AT SEA. Eight Members of Her Crew Reported Picked Up.

LONDON, Feb 20—The German bark Johann Friedrich, Capt Lamiek, hence January 3rd for Philadelphia, has been abandoned at sea. Eight members of her crew are reported to have been picked up at sea on February 12 150 miles east of the Azores and just landed at Cete by the British steamer Katherine, from Laros Stock January 29th for that port. The Johann Friedrich was formerly the American bark William M Seed, and was built at Bath, Me, in 1877, registered 1,236 tons and hailed from Bremen.
