

Bylaw No. 3340

To provide for the issue of \$5,000 debentures for the purpose of providing a Hospital for Consumptives:

WHEREAS, it is expedient to provide for the purchase of lands and buildings in or near the City of London for a Hospital for Consumptives, and for the purchase of the necessary land and the erection thereof of the necessary buildings for a Hospital for Consumptives, the cost whereof will not exceed \$5,000;

And whereas, by an act passed by the Legislature of the Province of Ontario, in the sixth year of his Majesty's reign, and chapter 76, and known as "The City of London Act, 1906," it is by Section 22 thereof provided that the limit of the borrowing power of the said corporation shall, notwithstanding the provisions of any act or law to the contrary, be fourteen per centum of the assessed value of the whole rateable property of the said City of London, as shown by the last revised assessment roll for the time being of the said city;

And whereas, it is by Section 23 of the said last-mentioned act provided that in calculating the amount of the indebtedness of the said corporation for the purpose of ascertaining if the limit of its borrowing power, as fixed by the next preceding section, has been exceeded, the net amount of its indebtedness for waterworks purposes being the sum of \$58,500.38, and any liability for the purpose of improvement debentures, issued by the said corporation, except such portion thereof as is payable by the said corporation at large, shall not be reckoned as part of such indebtedness, but shall be excluded in computing the same;

And whereas, the amount of the general debenture debt of the city, exclusive of its indebtedness for waterworks purposes, or the said sum of \$58,500.38, and exclusive of its local improvement debenture debt, except such portion thereof as is payable by the said corporation at large, amounts to \$2,291,476.71, of which no portion of the principal or interest is in arrears;

And whereas, the said sum of \$5,000 is the debt intended to be created by this bylaw;

And whereas, it will require the sum of \$122.50 to be raised annually for a period of thirty years, the currency of the debentures to be issued under and by virtue of this bylaw, to pay the interest of the said debt, and the sum of \$36.55 to be raised annually during the said period for the forming of a sinking fund for the payment of the debt created by this bylaw, making in all the sum of \$159.05 to be raised annually as aforesaid;

And whereas, it is necessary that such annual sum of \$159.05 shall be raised and levied in each year during the said period of thirty years by a special rate sufficient therefor on all the rateable property in the City of London;

Be it therefore enacted by the Municipal Council of the Corporation of the City of London as follows:

1.—It shall be lawful for the Mayor of the City of London, and the City Treasurer, to cause any number of debentures to be made for the purpose of money to be required for the purposes aforesaid, either in sterling money of Great Britain, or in the currency of Canada, payable in gold coin, for not less than one hundred dollars currency or twenty pounds sterling each, and not exceeding in the whole the said sum of \$5,000; and the said debentures shall be sealed with the seal of the said corporation, and be signed by the Mayor and Treasurer.

2.—The said debentures shall bear date the 20th day of June, A. D. 1909, and shall be made payable on the 30th day of June, A. D. 1929, in Canada, Great Britain or elsewhere, and shall have attached to them coupons for the payment of interest, the coupons for the first year shall bear interest at the rate of four and one-quarter per centum per annum from the date thereof, which shall be payable half-yearly on the 30th days of June and December in each year at the place where the said debentures shall bear interest.

4.—This bylaw shall take effect on, from and after the passing thereof;

5.—That the votes of the electors of the said City of London will be taken on this bylaw on Monday, the 4th day of January, A. D. 1909, commencing at the hour of 9 o'clock in the morning and continuing until 5 o'clock in the afternoon, at the deputy returning officer's office, hereinafter named, who shall be the deputy returning officer, that is to say:
