Brother-in-Law Explains the Incidents at Apartment.

WOMEN QUESTIONED

Evidence At Inquest Fails To Reveal Exact Cause of Death.

Montreal, June 2 .- The coroner's jury which investigated the death of Dr Ramsay Rankin of Stratford, Ont., from wounds, in the Western Hospital yes-terday, this afternoon brought in a verdict of accidental death. After being warned by Coroner Mc-Mahon that as he might be suspected by the police of being in some way ponsible for the death of Dr. Rankin his brother-in-law, Roy William Mc Eachren of Toronto, announced at the inquest this afternoon that he wanxious to tell everything he kne about incidents occurring on Tuesdanight in which he and the doct


