Order in Council P.C. 2722, dated September 15, 1939: amending Order in Council P.C. 2515, dated September 3, 1939, which appointed Walter S. Thompson, Esquire, as Chairman of the Censorship Co-ordination Committee—changing his title to Director of Censorship.

Order in Council P.C. 2734, dated September 18, 1939: appointing David C. Dick, Esquire, of Cobourg, Ontario, as Wool Administrator.

Order in Council P.C. 2735, dated September 18, 1939: restricting export of certain kinds of wool.

Order in Council P.C. 2757, dated September 20, 1939: appointing Miss E. H. Kearns, presently employed in the office of the Auditor General, as Registrar of all Orders in Council passed under the War Measures Act.

Order in Council P.C. 2773, dated September 20, 1939: appointing W. R. Campbell, Esquire, of Windsor, Ont., Chairman of the War Supply Board, and Robt. C. Vaughan, Esquire, of Montreal, Que., as Vice-Chairman and Director of Purchasing of the War Supply Board, to serve without salary.

Order in Council P.C. 2785, dated September 20, 1939: restricting exportation of certain articles from Canada which might be deemed capable of being converted into, or made useful in the production of, munitions supplies for enemy countries.

Order in Council P.C. 2788, dated September 21, 1939: respecting the powers to be exercised by the two Associate Acting Deputy Ministers of National Defence; and also allowances to dependents thereof.

Order in Council P.C. 2815, dated September 22, 1939: requisitioning of ships, etc., and appointing an Advisory Board in connection therewith.

Order in Council P.C. 2825, dated September 25, 1939: appointment of Judge F. L. Smiley, W. P. J. O'Meara, K.C., and J. Fortier, as Members of an Advisory Committee to consider objections made *re* arrest of persons under the Defence of Canada Regulations—allowances.

Order in Council P.C. 23/2838, dated September 26, 1939: exempting expense account of R. C. Vaughan, Esquire, as Chairman of the Defence Purchasing Board, from July 14 to August 24, 1939, inclusive, from the Requirements of the Travelling Expense Regulations; and subsequently granting an allowance of \$20 per diem from August 25, 1939.

Order in Council P.C. 2845, dated September 25, 1939: regulating sales tax on gas and electricity.

Order in Council P.C. 2852, dated September 25, 1939: amending Foreign Exchange Control Order, respecting the sale of foreign securities.

Order in Council P.C. 2853, dated September 25, 1939: authorizing purchase of British Columbia and Nova Scotia apples, and entering into agreements with the Okanagan Federated Shippers Association Incorporated, and the Central Selling Agency in Nova Scotia in connection therewith.

Order in Council P.C. 2876, dated September 27, 1939: appointing Captain Joseph Gustave Raymond as Vice-Chairman of the Dependents' Allowance Board in place of Lieut.-Col. Hugues Lemoyne deMartigny.

Order in Council P.C. 2881, dated September 27, 1939: authorizing a Proclamation setting apart Sunday, October 8, 1939, as a day of humble prayer and intercession to Almighty God touching the War in which Canada is now engaged.
