*Clause 17:*

(A) Strike out line 21, on page 10, and substitute the following therefor:

(B) Add, immediately after subclause (1), the following new paragraph:

"(a) The Governor in Council, in order to determine that a majority of producers of a farm product are in favour of establishing an agency, may request that each Province carry out a plebiscite of the said producers."

Strike out line 14, on page 13, and substitute the following therefor:

*Clause 22:*

Strike out Clause 22, on page 13, and substitute the following therefor:

"22. The objects of an agency are

(1) to promote a strong, efficient and competitive production and marketing industry for the regulated product or products in relation to which it may exercise its powers; and

(2) to have due regard to the interests of producers and consumers of the regulated product or products."

*Clause 23:*

(A) Strike out line 32, on page 13, and substitute the following therefor:

"(a) purchase any regulated product in relation to which it may exercise its powers and any farm product, wher-

(B) Add, immediately after paragraph (e) of subclause (1), on page 14, the following new paragraphs:

"(f) where it is empowered to implement a marketing plan, make such orders and regulations as it considers necessary in connection therewith, but all such orders and regulations shall, in the case of orders and regulations that are of a class to which paragraph (d) of subclause (1) of section 7 is made applicable, be submitted to the Council before the making thereof, and in any other case, be submitted to the Council either before or after the making thereof and
