ICE-BREAKER CONTRACT.

Mr. VERVILLE:

1. Has the Government given by contract the erection of an ice-breaker? If so, to whom, and at what price?

2. Has the Government attached a fair wage schedule on said contract? If not, why not?

Mr. HAZEN:

1. Yes. Messrs. Canadian Vickers, Ltd., Montreal, \$998,583.00.

2. There is no fair wage schedule embodied in the said contract. The matter is, however, covered by a clause in the contract as follows:

All workmen labourers or other persons who perform labour in the construction of the work hereby contracted for shall be paid such wages as are generally accepted as current from time to time during the continuance of the contract for competent workmen in the district in which the work is being performed, and if there is current rate in such district, then a fair and

reasonable rate, and shall not be required to work for longer hours than those fixed by the custom of the trade in the district where the work is carried on, or if there is no custom of the trade as respects hours in the district, then fair and reasonable hours except for the protection of life or property or with the consent of the minister on due cause shown. In the event of a dispute arising as to what is the current or a fair and reasonable rate of wages or what are the current hours fixed by the customs of the trade or fair and reasonable hours, it shall be determined by the Minister of Labour, whose decision shall be final.
