4. What is the frequency with which such samples are taken?

6. How many people are engaged in performing such tests?

3. Has the federal department of labour received complaints from either contractors or trade unions or any other organizations in the past 18 months about this particular problem, outlined in question 2, and, if so, what are the organizations, and on what date did they make their representations?

MANITOBA—RELOCATION OF INDIANS BECAUSE
OF POWER DEVELOPMENT**Motion No. 6—Mr. Orlikow:**

That an humble address be presented to His Excellency praying that he will cause to be laid

before this house a copy of all correspondence, telegrams and other documents exchanged between the federal government or any agency or branch thereof and any other government, person or organization since January 1, 1959, relating to the proposal by the government of Manitoba or the Manitoba hydroelectric board to move the Indians from their present reserves at Cedar Land and Moose Lake to make way for the Grand Rapids power development.

Motion agreed to.

That an humble address be presented to His Excellency praying that he will cause to be laid before this house a copy of all correspondence and reports on the site of the 1967 world fair exchanged between the government and the following other governments or bodies concerned: (a) international joint commission, (b) St. Lawrence seaway authority (United States and Canada), (c) St. Lawrence river pilots' association, (d) national harbours board, (e) Canadian National Railways, (f) Quebec hydro, (g) city of Verdun, (h) Canadian association for the protection of birds, (i) Department of Transport, (j) town of St. Lambert, (k) government of the province of Quebec, (l) Canadian World Exhibition Corporation.
