RESEARCH

REQUEST FOR INCREASED GOVERNMENT ASSISTANCE

Last evening on C.B.C. we heard that basic research in this country is one third financed by United States foundations. I am sure we all appreciate this aid, but in view of the importance of research to the continued prosperity of the country is it wise that there should be this dependency? Has the Prime Minister reached a decision to substantially increase university research grants this session and, if he has not, when will he do so?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, I listened to that statement by a very distinguished scientist in B.C. who has been honoured with a very distinguished award, and I was much surprised at the figures he used. I have already taken steps to inquire if those figures are correct, and the policy of the government in regard to assistance for research will be made known before long.

NORTHERN AFFAIRS

PREPARATION OF BILL AMENDING PRESENT LEGISLATION

On the orders of the day:

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I would like to ask the Minister of Northern Affairs and National Resources whether the bill to amend the Northwest Territories Act and the Yukon Act has yet been drafted.

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): Mr. Speaker, it is in process; yes.

Mr. Erik Nielsen (Yukon): As a supplementary question are we to understand from the minister's reply that the Northwest Territories Act amendments and the Yukon Act amendments are in process of being drafted, and that only?

Mr. Nielsen: May I put this supplementary question to the minister. Has the bill itself, with respect to these amendments to the Yukon and Northwest Territories Acts, been printed?
