HOUSE OF COMMONS

USE BY DEPARTMENTAL OFFICIALS OF PORTION OF GALLERY

Mr. Speaker: Order. The hon. member for Winnipeg South Centre yesterday questioned the propriety of certain departmental officials using the first row behind the press gallery for the performance of their responsibilities as departmental or ministerial officials. I indicated to the hon. member that I would look into the situation, and I have now had the opportunity of doing so.

There is a degree of uncertainty, as I indicated yesterday, in respect of the first row behind the press gallery; that is, whether it is an extension of the press gallery, an extension of the official gallery, or part of the general gallery.

In view of the uncertainty of the situation I took the opportunity to suggest that when space is available in the recognized official gallery the departmental officials should use it rather than other galleries for the exercise of their official responsibilities.

PRIVILEGE

MR. HALES—ANSWER TO QUESTION ON ORDER PAPER

Mr. A. D. Hales (Wellington South): Mr. Speaker, I rise on a question of privilege. In view of the fact that all of us in this house expect full, complete and correct answers to our questions, be they oral or written, I should like to bring to the attention of the house, the Prime Minister and his parliamentary secretary that I asked a written question to which I received an answer on Monday. Part of the question was:

Who are the auditors for the Company of Young Canadians and what yearly audit fees have been paid?

The answer to that part of my question was

The Auditor General. No fees are charged. 23033—792½

That is completely wrong because, as I recall, the act did not stipulate that the Auditor General would be the auditor, but that the Governor in Council would appoint an auditor for this organization. To the best of my knowledge no auditor has yet been appointed. I have brought this situation to the attention of the house because I feel we should receive full and correct answers.

Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): Mr. Speaker, in order to clarify this matter—and I am very sorry if my hon. friend thinks he has been misled in any way—let me say that during the current year payments on behalf of the Company of Young Canadians have been made through the comptroller of the treasury. As a result all these expenditures come under the scrutiny of the Auditor General. In succeeding years it will be necessary for the cabinet to appoint an auditor as provided in the legislation. In respect of the current year the answer given is quite correct.

ROYAL VISIT

DATES OF VISIT BY HER MAJESTY AND DUKE OF EDINBURGH

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, it will be recalled that on September 13 last it was announced from Government House that Her Majesty the Queen and His Royal Highness the Duke of Edinburgh had accepted an invitation of the government of Canada to attend ceremonies in our national capital, celebrating the 100th anniversary of confederation.

I am happy to be able to state now that the dates of the visit of Her Majesty and His Royal Highness have been confirmed. They will arrive at Uplands airport in the late afternoon of Thursday, June 29, and will remain in Canada until late in the evening of Wednesday, July 5. Her Majesty and His Royal Highness, on this occasion, will visit the national capital and will have one day, July 3, at Expo '67.

Her Majesty will address members of both houses of parliament assembled on the anniversary of confederation, Saturday, July 1
