**Mr. James A. McGrath (St. John's East):** In view of the importance of continuing discussions with France in connection with treaty rights off our east coast, especially in terms of implementing our pollution legislation, may I ask whether talks aimed at reaching a satisfactory settlement of this treaty which we inherited from Great Britain are still going on with the French government? If not, why not?

Having in mind the announced intention of the United States to proceed with a further massive nuclear test in the Aleutian area next fall and the increasing concern over this proposal in Alaska and British Columbia, will the minister check on this situation, particularly the reported danger of radioactive hydrogen leaking into the Pacific and contaminating its waters?

## ESTABLISHMENT OF CENTRAL MORTGAGE BANK

**Mr. Lincoln M. Alexander (Hamilton West):** My question is addressed to the minister responsible for housing and it is supplemental to that asked by the hon. member for Broadview. In view of the minister's willingness to participate in the setting up of some form of central mortgage bank, as recommended by the task force on housing and urban affairs, which would be a base for new mortgage institutions and would lead to further liquidity, is it the hon. gentleman's intention to lay before this House legislation leading to the creation of such a central mortgage bank?

**Hon. Robert K. Andras (Minister without Portfolio):** We held an exploratory discussion in September with the approved lenders and again, the other day, with the trustee pension fund representatives, during which this suggestion was considered as a possible way to provide increased marketability for mortgages. It was not announced as government policy but it is an interesting proposition which we shall be exploring in more detail, and if the indications are that we should make this recommendation I will say so to my colleagues and, if accepted, naturally we would bring the matter before Parliament.
