DATE OF INCREASE IN FUNDS TO ALLOW AUXILIARY COAST GUARD ON WEST COAST TO OPERATE

Mr. John Reynolds (Burnaby-Richmond-Delta): Mr. Speaker, I have a question for the Minister of Transport which is a follow up to the question asked the other day about the coast guard auxiliary. Would the minister advise the House when we can expect a decision by cabinet regarding the coast guard auxiliary in view of the urgent situation on the west coast right now?

Hon. Otto E. Lang (Minister of Transport): Mr. Speaker, the establishment of the coast guard auxiliary is ongoing and has already begun. The current questions which are before cabinet are rather with regard to the total equipment available for the coast guard itself. The auxiliary role of a variety of vessels not directly associated with the government will always be of extreme importance. On the west coast, the auxiliary organization is now in an important phase of its introduction.

Mr. Reynolds: A supplementary question, Mr. Speaker. In view of the fact that the coast guard auxiliary, which was started in Delta and Richmond in my riding, has been stopped now due to lack of funds, can the minister say when there will be a decision of cabinet to put these funds in place so that they can continue to do the excellent work that both he and I agree they do?

Mr. Lang: Mr. Speaker, it will be perhaps within a matter of days, certainly within a matter of weeks.

REQUEST FOR PUBLICATION OF MINUTES OF MEETING OF ADVISORY BOARD ON CREATION OF BILINGUAL DISTRICT AT ST. CATHARINES

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, it would be my understanding that the body to which the hon. member refers is an automous body that is advisory to the government, and I do not think it would be appropriate for us to put any pressure on them.
