Madam Speaker: Order, order. I think the Hon. Member knows that he is presently abusing the rules—

Mr. Simmons: As is the Chair.

Mr. Nielsen: Withdraw!

Madam Speaker: He has stated his case, the Chair has ruled on his case, and I have suggested that he might transform it into a point of order but he refused to do so. The Hon. Member does not have a question of privilege. He should read the definition of privilege very carefully, and he will realize that he does not have a question of privilege.

Mr. Lewis: Madam Speaker, on a point of order, I wish to draw to your attention and to the attention of the House that during your recent remarks, when you suggested that the Member was abusing the rules of the House, the Hon. Member for Burin-St. George's (Mr. Simmons) said "And so is the Chair", or something similar. I would ask him to withdraw those remarks.

Madam Speaker: Well, I did not hear the Hon. Member say those words.

Mr. Nielsen: Hansard did.

Madam Speaker: I will ask him if he did say those words, and if he did say them, of course he will have to withdraw them. I did not hear them, but I will ask the Hon. Member to tell me on his honour whether or not he said them.

Mr. Simmons: Madam Speaker, I believe very deeply that in this matter the Chair abused the rules, and I said so. However, if the Chair finds that statement of my belief to be in unparliamentary terms, then I withdraw without equivocation. But you cannot hang me for what I am thinking.
